The diamond surface glove can be in contact with all types of food. Having achieved correct results and below the limits established according to EU Regulation No. 10/2011, in the simulants established by the regulations.

The raw materials used for the manufacture of the glove comply with the conditions described in the legislation and are included in the positive lists of monomers and other starting substances and additives authorised for the manufacture of materials and articles intended to come into contact with food, not producing specific migration according to the values defined in the legislation.

The polymeric materials were used in proportions that ensure that the general layout for the foodstuff will not produce specific **migration** greater than the values defined in the legislation. Testing Conditions for Food Contact Materials, by the European Union, issued in 2023 JRC134290. Conditions for the specific migration of plastics and plastic-containing articles, of foreseeable use, from the "worst case" by the consumer, followed by the application of the principles of Sections 2.1.3 and 2.1.4 of Annex V to Regulation (EU) No 10/2011. 30 minutes 40°. To ensure comparability of the measurement results reported in the framework of the implementation of official controls for FCM (Regulation (EU) 2017/625).

The tested glove referenced as Gentle Touch Grip Nitrile Glove size M, with an average global migration value of 4.4 +/- 0.4 and an individual value of 4.2, with values below 10mg set by regulation 10/2011 on plastic materials and articles intended to come into contact with food and Commission regulation (EU) 2020/1245 issued on September 2, 2020.

The control and test reports have been prepared by the Notification Body Aitex, located in Alicante, Alcoy with certified number 2023TM6718 and by LQM in 2025
